

VISITLETHBRIDGE.COM FREE TO EXPLORE DRAW

DRAW RULES and REGULATIONS FOR “VISITLETHBRIDGE.COM FREE TO EXPLORE DRAW” (the “Draw”) This Draw is sponsored by Lethbridge Lodging Association (the “Draw Sponsor”). The Draw runs from July 17, 2020 to (the “Draw Period”) to September 30, 2020 being the (“Draw Closing Date”). The Initial draw date will be October 5, 2020.

1. ELIGIBILITY: The Draw is open to Canadian citizens who are 18 years of age or older except: (i) employees, agents and representatives of the Draw Sponsors, each of their associated companies and agencies and the independent judging organization (collectively, the “Draw Entities”); (ii) members of the immediate families of the aforementioned employees, agents and representatives or persons with whom such employees, agents or representative’s contractors are domiciled. “Immediate family members” are defined as spouse, common-law spouse, parents, siblings, children and cohabitants.

2. HOW TO ENTER: Purchase at a participating restaurant is necessary. To enter visit the Draw page on the VisitLethbridge.com website (<https://www.visitlethbridge.com/freetoexplore>). Entrants must fill in all mandatory Draw entry fields, including birth date, confirming rules and regulations were read and understood as well as submit a photo of the guest check from the participating restaurant. Entries will be rejected if they do not wholly complete the Draw entry form fields on the webpage entry form during the Draw Period. The Draw Sponsors are not responsible for lost, late or incomplete entries and any such entries will be void. Entries are limited to the Draw period and winner must be able to redeem the prize as awarded without substitutions. All entries must be received on or before the Draw Closing Date.

3. DRAW: Draw from entries will be made on October 5, 2020 in Lethbridge, Alberta from all eligible entries received on or before the Draw Closing Date. If this confirmation cannot be made, consecutive selections will be made from all remaining eligible entries until the prize has been issued. The odds of winning the Prize depend on the number of entries received.

4. PRIZE WINNERS: Only the selected entrant will be notified. In order to win, the selected entrant must show a valid driver’s license or other government issued photo identification as evidence of identity. The selected entrant will be required to sign a Declaration and Release of Liability Form confirming compliance with the Official Draw Rules and Regulations, releasing the Draw Sponsor and its affiliated companies, and their advertising and promotional agencies from any liability resulting from the awarding of the Prize and confirming acceptance of the Prize awarded. Any and all travel costs are the winner’s sole responsibility.

5. PRIZE: There is ONE Grand Prize to be won with approximate retail value of \$1,000 in the form of a Visa Gift Card.

All Prizes must be accepted as awarded, without substitution and are not transferable or redeemable for cash or allowed to be sold. The Draw Sponsors have the right to substitute the prizes in whole or in part in the event that all or any of the components of the Prize is unavailable. In the event that the winner is unable to redeem any or all of the Prize components due to reasons beyond the control of the Draw Sponsors, their employees, representatives, agents and all parties associated with this Draw, no cash alternative, other compensation, substitution or transfer of Prize will be provided.

6. By entering this Draw the entrants and participants automatically agree to accept and abide by these Rules and Regulations. All decisions of the Draw Sponsors with respect to any aspect of this Draw, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this Draw.

7. Draw is subject to all applicable federal, provincial and municipal laws. None of the Draw Sponsors accepts any responsibility for lost, stolen, delayed, late, damaged or misdirected entries or for any failure of the website during the Draw Period, for any problems or technical malfunction of any telephone network or lines, computer online systems, servers, access providers, computer equipment, software, failure of any entry to be received on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof including any injury or damage to an entrant's or any other person's computer related to or resulting from entering or attempting to enter the Draw. Entries are subject to verification and will be declared invalid if they are illegible, mechanically or robotically programmed or reproduced, mutilated, forged, falsified, altered or tampered with in any way. The Draw Sponsor reserves the right, at its sole discretion and without notice, to disqualify any entry and to modify, terminate, or suspend this Draw for any reason including if a virus, bug, non-authorized human intervention, action of entrant(s), or other cause corrupts or impairs the administration, security, fairness, or proper play of the Draw, and, if the Draw is modified, terminated, or suspended, select winners from those eligible entries received prior to the event requiring such modification, termination, or suspension.

8. The Declaration and Release of Liability document will release and save harmless the Draw Sponsors from and against any liability whatsoever in connection with the conduct of this

Draw and the awarding and/or use of any prize. The return of any prize/prize notification as undeliverable or noncompliance with the terms of these Official Rules may result in disqualification and at Draw Sponsors' discretion, selection of an alternate entrant.

9. LIMITATION OF LIABILITY: Draw Sponsors are not responsible for lost or late entries or Declaration and Release forms, or for any typographical, or other error in the printing of the offer, administration of the Draw, or announcement of the prize, or for technical, hardware, or software malfunctions, computer virus, bugs, tampering, unauthorized intervention, fraud, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, garbled, or delayed electronic communications whether caused by the sender or by any of the equipment or programming associated with or utilized in this Draw, or by any human error which may occur in the processing of the entries in this Draw, or any other cause beyond the reasonable control of Draw Sponsors that interferes with the proper conduct of the Draw as contemplated by these Official Rules. If, in the Draw Sponsors' opinion, there is any suspected or actual evidence of tampering with any portion of the Draw, or if technical difficulties or any other factor including accident, printing, administrative, or any error of any kind compromises the integrity, administration, or conduct of the Draw, the Draw Sponsors reserve the right to modify, cancel, or suspend this Draw without prior notice or obligation. Any attempt to deliberately damage any website or to undermine the legitimate operation of this Draw is a violation of criminal and civil laws and should such an attempt be made, the Draw Sponsors reserve the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution. Draw Sponsors reserves the right to disqualify a person if he/she enters the Draw or tries to do so by any means contrary to these rules or which would be unfair to other entrants or where entries or votes are generated by any mechanical or automated means. Refusal to accept a prize releases the Draw Sponsors, as well as their respective directors, officers, and employees, of all responsibility and obligations toward the winner of such prize. In no event shall Draw Sponsors be held to award more prizes than what is mentioned in these rules or to award prizes otherwise than in compliance with these rules. Draw Sponsors shall assume no liability whatsoever for any situation in which their inability to act results from an event or situation unforeseeable or beyond their control, including but not limited to force majeure, a strike, lockout, or any other labour dispute at their location or the locations of the businesses whose services are used to hold this event. In the event of any dispute concerning the operation of any element of the Draw or these Draw Rules, the decision of the Draw Sponsors will be final.

CONDITIONS OF ENTRY: Acceptance of a prize constitutes permission for the Draw Sponsors and their agencies to use winner and guest's names, cities and provinces/territories of residence, and likenesses for purposes of advertising and publicity in any and all media – now or hereafter known throughout the world in perpetuity – without further compensation, notification, or permission, unless prohibited by law. All information requested by and supplied by each entrant must be truthful, accurate, and in no way misleading.
